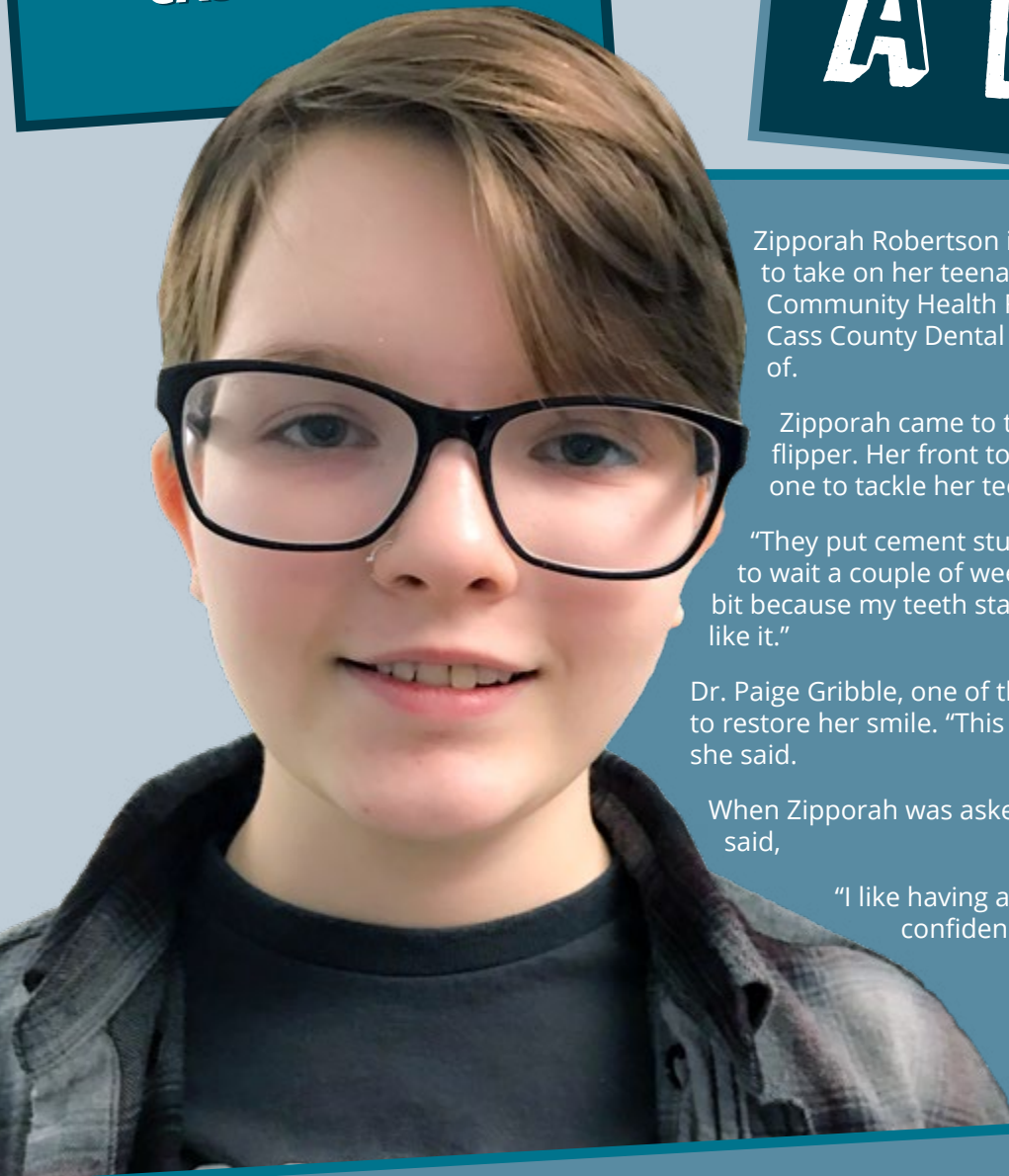


FIT FOR A FLIPPER

Dr. Paige Gribble, one of the clinic's dentist, worked with Zipporah to restore her smile. "This is huge for a teenager's confidence," she said.

When Zipporah was asked how her flipper made her feel, she said,

Mark your calendars for Cass Community Health Foundation's 26th Annual 5K for Health Saturday, May 2 at Belton Regional Medical Center! The 5K raises money for patients at CCHF's safety net dental clinic, Cass County Dental Clinic.

The Clinic is the first and only safety net dental clinic in Cass County, Missouri with locations in Belton and Harrisonville. Children aged 0-20 who are insured through Medicaid or are low-income uninsured are served at both clinic locations.

Sara Jones of the Belton School District will serve as chair of the event and Al Voelker of the Raymore-Peculiar School District will serve as co-chair the event. Chase Coffman, NFL tight-end, Missouri Hall of Famer and Ray-Pec High School graduate, will return as honorary chair.

Community members have the option of walking or running in the 5K and can create personal fundraising pages to support their participation. Registering as a walker is free, but everyone is asked to make a personal donation. Runners must pay an entry fee and will receive a 5K t-shirt. Walkers raising \$100 or more in donations will receive a 5K t-shirt. Additional prizes will be awarded to all participants raising \$150 or more.

Following the 5K, all walkers and runners are invited to enjoy a morning celebration that includes food provided by Cosentino's Price Chopper, music, prizes and a community health fair. The health fair, sponsored by Belton Regional Medical Center, will feature fun activities for all members of the family.

The 5K will begin and end at Belton Regional Medical Center. Check-in begins at 7:30 a.m. and the 5K begins at 8 a.m.

During the 2018-2019 academic year, Cass Community Health Foundation screened **4,885 students** in Cass County and Grandview schools. The screenings are free and offer fluoride varnish application with parental consent as well as oral health education and information.

In 2019, Cass Community Health Foundation awarded **\$52,250 in scholarships** to 40 high school seniors from the Cass County and Grandview area who are pursuing careers in health care.

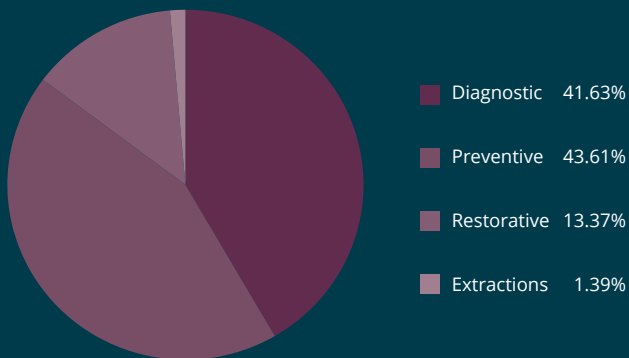
2019 IN REVIEW

Treated 3,320 underserved children through 5,733 dental visits through our Cass County Dental Clinic.

Screened 4,885 children during our 2018-2019 school year dental screenings, applied fluoride varnish to 2,993 children who had parental consent and identified 1,136 children in need of further dental care.

Awarded \$52,250 in scholarships to 40 students pursuing nursing or other health care careers through our health care scholarship program.
