Before it was a brick and mortar location, she worked out of the Cass Community Health Foundation office to help get the space up and running. She's seen the clinic doors open for many families and has created relationships with a lot of patients, especially the Verstraetes.



Just after the new year, Jasmine and Madison were walking back to a dental treatment room at the Cass County Dental Clinic Belton location catching up.

"Did you get everything you wanted for Christmas? How is tennis going? How is volleyball going?"

Tiffany Verstraete, mom of clinic patients Joshua, Caleb, Madison and Mackenzie, has observed a strong connection between Jasmine and her children.

"They always fight over who gets to have Jasmine. We'd be here all day if they all got their way," Tiffany said.

After the school activities and holiday stories were shared, Madison mentioned her brother Joshua. Joshua lost his insurance when he turned 19. His tooth was bothering him; a filling fell out; the pain worsened. His family and the clinic tried to reinstate his insurance without success. Jasmine made a few phone calls, found a willing endodontist and Cass County Dental Clinic paid for half of the procedure.

"I'm very grateful. The Clinic told us we've been good clients and we take this seriously," Tiffany said. "I felt like it was a compliment -- that they would step up and try and do something like that."

Before the appointment ended, Madison shared that her brother was getting his root canal that same day.

"I don't want Josh to experience anymore pain because I like your family too much," Jasmine said.

Jasmine and Madison walked out to the waiting area to meet Tiffany and Mackenzie, Madison's twin sister. Jasmine reported a good bill of oral health for both girls and stretched out her arms to invite them closer for a photo.

"Let's take a photo with some of my favorite twins," Jasmine said. "But don't tell my twins that."

After the photo, she wished the Verstraetes a happy new year and went back to work, preparing for another appointment, another child and another smile to shape.

# 25<sup>TH</sup> ANNUAL

**Cass Community Health Foundation (CCHF) is hosting the 25th Annual 5K for Health Saturday, May 4 at Belton Regional Medical Center. The 5K raises money for patients at CCHF's safety net dental clinic, Cass County Dental Clinic.**

The Clinic is the first and only safety net dental clinic in Cass County, Missouri with locations in Belton and Harrisonville. In 2018, more than 3,600 low-income children aged 0-20 were served at both clinic locations.

Former Harrisonville mayor Kevin Wood and Sara Jones of the Belton School District will chair and co-chair the anniversary event. Chase Coffman, NFL tight-end, Missouri Hall of Famer and Ray-Pec High School graduate, will return as honorary chair.

Community members have the option of walking or running in the 5K. All participants can create personal fundraising pages. Registering as a walker is free, but everyone is asked to make a personal donation. Runners must pay an entry fee to cover the costs of t-shirts, time chips and bibs. All runners will receive a 5K t-shirt by paying the entry free. Walkers raising \$100 or more in pledges will receive a 5K t-shirt. Additional prizes will be awarded to all participants raising \$150 or more.

Following the 5K, all participants are invited to enjoy a morning celebration that includes food provided by Cosentino's Price Chopper, music, prizes and a community health fair. The health fair, sponsored by Belton Regional Medical Center, will feature fun activities for the entire family including Chris Cakes.

The 5K will begin and end at Belton Regional Medical Center. Check-in begins at 7:30 a.m. and the 5K begins at 8 a.m.

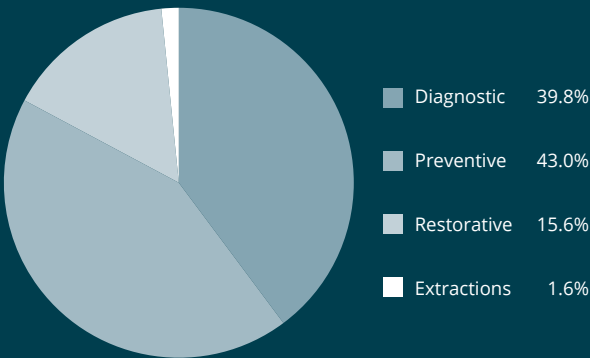
# 2018 IN REVIEW

Treated 3,615 underserved children through 6,831 dental visits through our Cass County Dental Clinic.

Screened 4,774 children during our 2017-2018 school year dental screenings, applied fluoride varnish to 2,617 children who had parental consent and identified 809 children in need of further dental care.

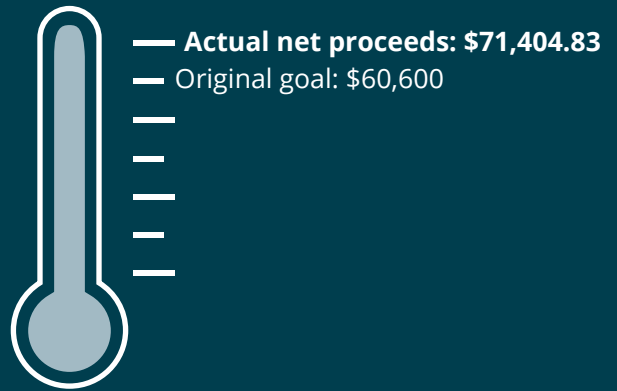
