Cass County and surrounding area community members helped Cass Community Health Foundation raise more than \$75,000 for its safety net dental clinic's 10th anniversary.

In July, Cass Community Health Foundation and Cass County Dental Clinic launched a campaign to celebrate the important milestone. The campaign, Cass County Dental Clinic's 10th Anniversary Celebration: A Dental Home for a Decade, allowed community members to help secure a future for the dental clinic and learn more about the care it provides.

Cass Community Health Foundation's Cass County Dental Clinic was established as Cass County Missouri's, first safety net dental clinic in 2011. The first location opened in Belton with a second location opening in Harrisonville in 2015. The clinic serves thousands of low-income children and teens each year. In 2021, Cass County Dental Clinic treated nearly 3,700 children in the community.

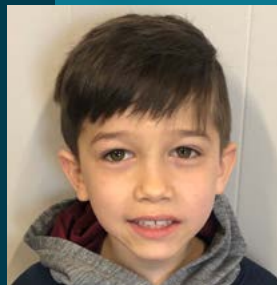

# A YEAR OF CELEBRATION



## EXPANSION INTO TELEDENTISTRY

Cass Community Health Foundation completed its piloted tele-dentistry program at the end of the 2020-2021 academic year. With funding from the Missouri Department of Health and Senior Services and Delta Dental of Missouri, Cass County Dental Clinic staff visited select Cass County and Grandview schools to provide essential oral health care to students.



## RETURN TO DENTAL SCREENINGS

Cass Community Health Foundation resumed its annual school-based dental screening program in Cass County schools in the fall of 2021. The program had been on hold since March 2020 when the COVID-19 pandemic began.



## 5K FINDS NEW LOCATION

The 27th Annual 5K for Health was hosted at a new location for the first time in 2021. Walkers and runners from Cass County and the surrounding area celebrated Cass County Dental and its 10th anniversary at Southwick Stadium in Belton on September 11.



## A PATIENT PARTY

Cass County Dental Clinic hosted a patient appreciation celebration in honor of its 10th anniversary. On August 4, Cass County Dental Clinic patients were invited to the Belton clinic. Families were encouraged to drive through the clinic parking lot and receive free dental supplies, a take-home craft, and ice cream.



## TO OUR FRIENDS

Like many area non-profits and businesses, we continued to experience challenges in 2021 due to the pandemic. Despite these challenges, Cass County Dental Clinic served 3,659 children and teens in 2021 - the highest served in any year since we opened this safety net

dental clinic 10 years ago!

Our school-based dental screening program regained momentum as schools allowed visitors back into buildings. We educated and screened more than 2,000 students in five school districts, identifying 25% as having unmet dental needs.

Our teledentistry services became a permanent program. It provides diagnostic and preventive services in schools. Teledentistry removes barriers related to transportation, time away from work, childcare, and reduces the amount of time children miss from the classroom.

We implemented a new in-office sedation program with Premiere Dental Anesthesiology. Offering services on-site reduces number of visits and travel to specialists required for children who need sedation.

We want to thank our donors and volunteers for supporting our efforts to provide access to dental care in Cass County and the surrounding communities. We hope you will again help us put SMILES on the faces of the children we serve in 2022.

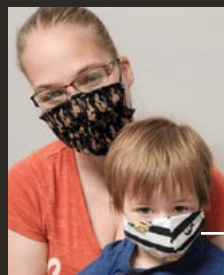

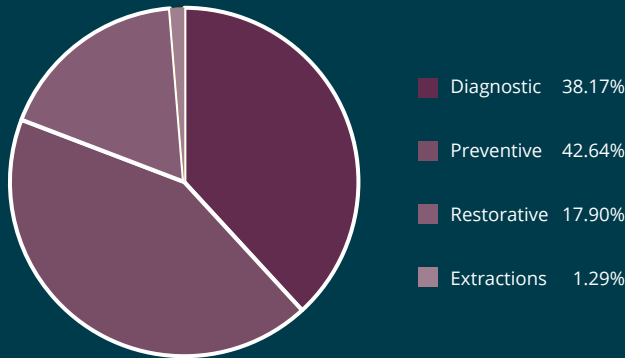

# 2021 IN REVIEW

Treated 3,659 underserved children through 7,107 dental visits through our Cass County Dental Clinic



Provided dental services for 174 students with Medicaid or no dental insurance in the Belton and Grandview school districts through a piloted school-based teledentistry program
