**Cass Community Health Foundation and its safety-net dental clinic, Cass County Dental Clinic, were honored as Business of the Year by the Belton Missouri Chamber of Commerce. Since 2011, Cass County Dental Clinic has provided dental care to children and teens who are insured by Medicaid or from underserved backgrounds. The clinic operates locations in Belton and Harrisonville and serves thousands of Cass County families each year.

This recognition comes at a pivotal moment for the organization. In April 2025, Cass Community Health Foundation opened its brand-new, expanded dental clinic in Belton. The new facility increases patient capacity and allows the clinic to better meet the growing needs of families throughout the community.

We opened the brand-new Cass County Dental Clinic at 1000 Markey Parkway in Belton, MO. The clinic began treating patients on April 21. This achievement was celebrated with a successful grand opening on May 27, when supporters, community members, staff, and local and state dignitaries gathered for tours, a ribbon-cutting ceremony, and festivities. We provided quality dental care to 2,732 children and teens at Cass County Dental Clinic in 2025.

We provided free dental screenings for 5,694 students in 33 Cass County and surrounding area schools during the 2024-2025 academic year. The program was made possible by 115 volunteers, totaling 677 hours of volunteer time.
